THE METRO ATLANTA CHAMBER PUBLIC POLICY TEAM ADVOCATES FOR POLICIES THAT ADVANCE OUR ECONOMY, GROW OUR TALENT, AND ENHANCE OUR COMMUNITY.

## BUSINESS CLIMATE

- Ensure a competitive and consistent tax environment that encourages business and job creation, recruitment, retention and expansion.
- Bolster economic development tools and promote inclusive growth to start, recruit and retain businesses and events.
- Foster innovation and drive entrepreneurship by expanding venture capital funding, and entrepreneurial assistance resources, particularly in underrepresented communities.
- Support a fair and stable legal climate for business.
- Protect Georgia's top-rated business climate against legislation that interferes with business operations or is discriminatory in nature and harmful to our ability to create, recruit and retain jobs and talent.
- Ensure the ability of private property owners and operators of land to determine whether to permit weapons on that property.

## INFRASTRUCTURE

- Expand long-term dedicated state funding for transit improvement and expansion.
- Strengthen supply chains through comprehensive freight logistics.
- Ensure air quality by advocating for a clean, safe, reliable, affordable, and diverse energy portfolio for Georgia.
- Increase access to reliable communications networks for businesses, families, and students.
- Establish Georgia as a leader in clean technology, including electric vehicles.
- Ensure Georgia maintains leadership in cybersecurity and digital technologies.
- Advance Georgia's long-term water strategy and the responsible management of all waste streams.

## TALENT DEVELOPMENT & EDUCATION

- Develop a globally competitive talent pool by aligning workforce and education systems, agencies, and industry partners to deliver talent for high-demand careers.
- Cultivate strong public-private partnerships from early to post-secondary education to ensure career awareness and opportunities.
- Promote economic mobility and remove barriers to employment and educational attainment for all learners, particularly those in underrepresented communities.
- Support affordable, high-quality education from early learning to K-12 and promote post-secondary training focused on in-demand careers aligned with state and local workforce needs.

## THRIVING COMMUNITY

- Enhance Atlanta's sports community through efforts including securing long-term funding for major sporting events and legalizing online sports betting.
- Support strategic reforms to the criminal justice system to minimize recidivism and fiscal demands while maximizing rehabilitation, re-entry, and public safety.
- Combat human trafficking by raising awareness and supporting survivors.
- Support initiatives improving access and quality of healthcare for low-income and uninsured Georgians.
- Encourage policies that improve public health, including mental health.
- Increase attainable workforce housing supply.
- Promote policies that align with ATL Action for Racial Equity.
